PAYMENTS: Check (\$50 fee for all returned checks) or credit card (3.5% processing fee)

STALLION, MARE & GELDING CLASS RULES:: Horses may be ridden one or two handed in a NRHA legal bit. Exhibitor will be excused from the arena at the allotted time and no training equipment is permitted.

DOGS: must be on leash at all times

Entries close the sooner of: 5:00 p.m. the night before or at the end of the last class.
